# **Market Intelligence**

- Several companies are exploring strategic alternatives, including Albea (Sun Capital Partners), Brook & Whittle (RFE Investment Partners), Caraustar (HIG Capital) and Fort Dearborn (KRG Capital)
- 6/2016 RPC Group (LSE:RPC) is seeking further acquisitions to extend its presence in Europe and outside the continent in specific niches or to follow its customers' global expansions
- 6/2016 Huhtamaki Oyj (HLSE:HUH1V) is actively seeking to deploy €500m on acquisitions in Southeast Asia and Africa and also has earmarked €160m for acquisitions in other growth markets, including flexible packaging
- 6/2016 Intertape Polymer (TSX:ITP) announced it is evaluating acquisitions to grow its footprint outside North America

- 6/2016 Multi-Color (NasdaqGS:LABL) expects to complete four to six acquisitions totaling \$100m of revenue in fiscal 2017
- 5/2016 **PSB Industries** (EPA:PSB) is seeking to acquire packaging manufacturers in the luxury, health and food sectors, as well as in the fine chemicals industry
- 4/2016 Ardagh Group has agreed to acquire a variety of assets (totaling \$3.4b) in Brazil, Europe and the U.S. from Ball and Rexam
- 4/2016 Supremex (TSE:SXP), a manufacturer of custom envelopes, packaging and specialty products, is seeking acquisitions in the printing and binding markets
- 4/2016 CCL Industries (TSX:CCL.B) stated that it will consider making a larger, transformative acquisition in the near future


